The sanction is subject to the fulfillment of the following conditions in addition to the conditions intimated at the time of grant of provisional affiliation for secondary classes.

- 1. The school will provide additional suitable facilities for classes XI and XII as per requirements laid down in the rules.
- 2. It will increase the number of books in the Library and equipment in Laboratories Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
- 3. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
- 4. It will provide facilities for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
- 5. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
- 6. It will remit Annual fee of Rs. 1200/- regularly. (Increase of overseas Independent students to 50% p.a. and overseas Kendriya Vidyalaya @ Rs. 3,000/- p.a.). As per record annual fee received upto 31.3.2012
